The big news for Sky Pilots last year was the release of the Sky Pilot Manual and Handbook. Our website (LOTCS.ORG) has been updated so it is easier to get to the manual. At the top middle of the page, you will see *'Scratch N Search'* block. Type in *"Sky Pilot"* and you will be given two options. Click on the first option, and click on *'Manual'* tab. Then, just download the Manual/Handbook and print it double sided. I want to again thank the committee of Chaplains and Sky Pilots who helped me with this project. They include Dale Iannello, Jennifer Smith, Eric Shumaker and Tom Darling.

Another exciting item from the Manual/Handbook is a reporting system to record our efforts. Up until now, the Supreme Chaplain was one of the few Supreme C of A members who could not praise the good work of Cooties at all levels, because they had no information to do so. The reporting system will give me that information. To make a report, go back to the 'Scratch N Search' block; again type 'Sky Pilot', and select the second option. You will be given an easy to follow form to fill out and submit. Also notice that each Sky Pilot, at any level accounts for their own work. A local Pup Tent Sky Pilot does not have to go through the Grand Chaplain, although it is a good idea to pass the info to them also.

### From the Supreme Inspector

#### Listen Cooties,

I have been reappointed, and will serve as the Supreme Inspector for the 2016-2017 MOC Year. Please send all inspection reports to me. My contact information is at the end of this article. Inspection reports can mailed to me or scanned and sent to my email address attached as a word document or a pdf file.

Congratulations to the Grands that reached 100% inspected for 2015-2016 before Convention. We ended the 2015-2016 MOC year at 98.5% inspections completed, that means that there were only 5 Pup Tents out of 344 that did not get inspected this past year. I am very satisfied with the where we ended up.

I am aiming to reach an even higher level of inspections this year. If you would like to miss out on the phone calls and emails that will come from me reminding you to get your inspections in, then please get your Pup Tents inspected and get your reports in. Supreme does forward inspection reports that get sent there, but it would speed up the process and lessen the load at Supreme HQ if inspections were sent directly to me. Many of you are sending reports to past Supreme Inspectors such as Dave Wimmer or Don Lynch. This also slows the process. Pup Tents should be inspected by a person appointed by the Grand Inspector, and that person should not be a member of that Pup Tent. However, when distance is a problem, your Pup Tent can be inspected by someone in your Pup Tent if the Grand Inspector approves. This person cannot be a current Pup Tent Seam Squirrel or CCDB. Same applies to Black Pup Tents that are not part of a Grand. Please use the current inspection form that is on the website

Please send in inspection reports as they inspected and schedule them early in the MOC year. Thanks in advance for your MOC commitment and your cooperation on getting inspections completed early, it makes my job easier and I appreciate it.

#### MOC SUPREME GENERAL ORDER #1 2016-2017

1. Having been duly elected at the 97th Supreme Scratch held in Charlotte, NC July 30, 2016, I, James D. Malott, hereby assume command of the Military Order of the Cootie of the United States. All previous Supreme appointments have now expired. Cooties will now revert to their previous and proper tassels.

2. Cooties at all levels are reminded that the disassociation mandate of 1959 remains in full force and is still in effect.

3. Notice is hereby given that the logo, bug, official seal, hat and the name Military Order of the Cootie are the trademarked and copyrighted property of the Supreme Pup Tent, Military Order of the Cootie of the United States and may not be used without the express written consent of the Supreme Pup Tent. Violators of this order will be prosecuted to the fullest extent of the law.

4. Supreme Headquarters is established as being located at 604 Braddock Ave., Turtle Creek, PA 15145. Office hours at Supreme Headquarters are from 9 AM to 5PM Monday through Friday, Eastern Time. Supreme Headquarters, MOC is closed for all Federal Holidays.

5. The Supreme Budget was approved by the Supreme Council of Administration July 30, 2016 and is in effect.

6. Registered Delegates to the 97th Supreme Scratch who were unable to attend can request a copy of the 97th Supreme Ad Book for the cost of \$1.50 to cover postage while supplies last. The book will be mailed to the delegates who make the request.

7. In accordance with Supreme Policy, all Grands are to inform Supreme Headquarters of the dates and places of their Grand Scratch so that proper representation may be assigned. Completed forms are to be mailed or e-mailed to Supreme Headquarters no later than January 1, 2017.

8. There is a limited supply of 97th Supreme Scratch Pins available for \$4.00 each or 3 for \$10.00. This unique pin is truly a collector's item. Cooties who did not get a chance to purchase some at the Supreme Scratch can still complete their collection by sending a note with a check for the number of pins requested. Shipping and handling is FREE on this item.

9. In accordance with Supreme By-Laws, Section 534, and having failed to register at least 1 delegate, the following Pup Tents are in arrears to the Military Order of the Cootie of the US and subject to suspension if not received by Nov 30, 2016. AL 13, ID 3, IL 67, 82, KS 6, LA 19, 20, MI 96, MO 14, NJ 35, 57, ND 6, PA 33, 65, SC 6, TN 4, WI 3, 5, 38.

10. In Accordance with Supreme By-Laws Section 308, and having failed to submit an Election Report, the following Pup Tents are considered suspended until such report is submitted to Supreme Headquarters: CO 7, MS 11, NJ 35, ND 6, OH 72, 86.

11. Notice to all Cooties. There were 5 By-Law changes (B-2, B-3, B-4, B-5 & B-7) adopted by the 97th Supreme Convention which will affect all levels of the Supreme Organization. You can order an updated edition of the Supreme By-Laws through the Supreme Supply Department.

12. Each Cootie will be assessed \$2.00, \$1.00 for the Supreme Commanders Special Project and \$1.00 for the annual maintenance fee MOC/MOCA House at the VFW National Home.

13. Pup Tents, Districts, Grand's, and Auxiliaries are reminded that they are to file IRS Form 990 within five months and fifteen days of the close of their fiscal year. Units whose income for 2015 was less than \$50,000.00 can elect to file Form 990-N an electronic informational return instead of a paper return. Those units whose income was over \$50,000.00 will still have to file the regular Form 990 or 990T.

14. Announcement is made of the TREK TO THE TOMB OF THE UNKNOWNS to be held on Sunday, OCTOBER 30, 2016 at Arlington National Cemetery of Arlington, Virginia. Additional details on Supreme Website.

15. The Supreme Council of Administration will meet at 9:00AM at the Sheraton Hotel, 900 South Orme St., Arlington, Virginia on Saturday, OCTOBER 29, 2016. All voting members of the Supreme Council are required to attend unless excused by the Supreme Commander.

16. Reporting for all programs are due no later than May 31, 2017.

17. Supreme Policy was approved by the Council of Administration on July 31, 2016 and is in effect.

Auxiliary to The Military Order Of The Cootie General Orders #1 - Series 2016-2017

- 1. Having been duly elected and installed as Supreme President of the Auxiliary to the Military Order of the Cootie I do hereby assume the duties of the office.
- All previous appointments are hereby declared null and void. All members not currently holding a Supreme Office shall revert to the proper tassels. Please refer to Supreme By-Laws Article VII, Section 707.
- 3. The Cootie Courier is recognized as the official method of communication between the Supreme Organization and all Supreme Officers, Chairmen, Grand and Local Auxiliaries. The General Orders and the President's message will be printed therein and are to be read at the first meeting following receipt of this of the current issue of the Cootie Courier and filed.
- 4. The Cootie Courier is available for free online at: https://lotcs.org/courier.html. Paper copies are available for a minimal subscription price of **\$10.00** to Supreme M.O.C. Headquarters, 604 Braddock Avenue, Turtle Creek, PA 15145.
- 5. Grand and Supreme District Secretaries: General Orders, Information Letters and Minutes should be sent to the Supreme President, Supreme Treasurer, Supreme Secretary, Supreme Senior and Junior Vice Presidents and the Supreme Hospital Commissioner. The audit and Treasurer's Report should be included in the minutes. If your Grand is within a Supreme District a copy may be sent to your Supreme District President.
- 6. Secretaries on all levels: Please forward any changes of Officers or addresses to the Supreme Secretary and Treasurer.
- 7. Supreme CDs containing the Supreme Roster and Program book will be available for purchase at Tomb Trek for \$5 each.
- 8. All official communications to the Supreme President must be in writing and come through proper channels. Any local Auxiliary should send their communications to their Grand President and the Grand President to the Supreme President. Any communication not sent through proper channels will be returned to the Grand President. All decisions will come from the Supreme President in writing.
- 9. Grand Presidents: Please send the Supreme President the dates of Testimonials, Homecomings and Grand C of A meetings, as well as any special functions your Grand may hold. I would like to make as many visits as the Supreme Budget will permit.
- 10. Grand Presidents and Supreme District Presidents: In the Supreme President Program Book, CD and website there is a form to request a Supreme Representative for your Grand or District Convention. Although it seems early, however, please send this form to the Supreme President as soon as you have the date and location of your Convention. This will aid in making Representative assignments and obtaining the best available airfares. The rest of the information can be sent to the Supreme President as soon as it becomes available. Please have these forms completed and sent in by December 31, 2016.
- 11. Grand Presidents and Auxiliary Presidents not in a Grand: In the President's Program Book, CD and website there is a form for adding and or replacing VAVS Representatives and Deputies. If any Representatives or Deputies are not able to regularly attend their VAVS meetings they should be replaced. The President is responsible for filling out this form and sending it to Supreme VAVS Representative Rebecca Wischmeyer.

- 12. Auxiliary Treasurers: Send Transmittals with the Per Capita tax to your Grand Treasurer and make the checks payable to the Grand MOC Auxiliary. Auxiliaries not in a Grand are to send the Transmittals directly to the Supreme Treasurer and the check for the Per Capita tax should be made payable to Supreme MOC Auxiliary. Please indicate on the application if this is a new, transferred or reinstated member. Please be sure that three Members have signed the application where indicated. If the application does not have all three signatures it will be returned for correction. Be sure the address on the application is complete and correct; we need to have a valid mailing address for all members. Please do not hold Transmittals. Send them in as soon as possible.
- 13. Presidents on all levels: The 2016-2017 President and Treasurer are the only authorized signatures on all accounts (checking, savings and CD's). All checks must have these two signatures. Checks should be imprinted with the Auxiliary Name, Number and State. Any checks received by Supreme not having two signatures will be returned.
- 14. Audits must be done quarterly and should be completed by October 15th, January 15th, April 15th and July 15th. The Audit form can be found in the current Supreme Program Book, CD and on the website. The Audit Form, bank statements, checkbook, Treasurer's Books and the books of the Secretary must be signed by at least two of the three elected Trustees. Local auxiliaries should forward the copies of the completed Audit Form to their Grand Treasurer. Auxiliaries not in a Grand should forward their Audits to the Supreme Treasurer.
- 15. Checks from the Supreme Auxiliary not cashed within 90 days of receipt will be voided. Any Auxiliary on any level sending bad checks to the Supreme Auxiliary will be responsible for the amount of the check and any fees incurred.
- 16. Inspectors: Inspections may begin immediately. Inform the Auxiliaries of the planned inspection date so they will be prepared. Inspections may not be done at a Council of Administration meeting, but must be done at a regularly scheduled meeting of the local Auxiliary. The Inspector should verify that the books of the Secretary and Treasurer are being audited. They should also verify that the office of the Treasurer is bonded and that the bond is in the possession of the President. The Hospital Chairman should have the figures for the Hospital Program available and the green copies of the Hospital Reports should be available as well. If a problem is found during the Inspection, you should notify the Grand President immediately. The Grand Inspector will mail or email Supremes' copy of the Inspection Form to the Supreme Inspector Marilyn Peck, 1737 West Beacon, Anaheim, CA 92804 E-mail: marilynpeck@earthlink.net
- 17. Hospital Chairmen: Send your reports in monthly to your Grand Hospital Chairman. Be sure that any report that is returned for correction has the date of receipt stamped on it so that it will not be considered late when it is corrected and returned. Grand Hospital Chairmen and Auxiliaries not in a Grand should send their reports to their District Hospital Commissioners.
- 18. Clown pins can be reported for three or more clown visits between May 1, 2016 and April 30, 2017 Visits must be reported on the Hospital Report and the Clown Request form sent to the Supreme MAMA Clown.
- 19. Auxiliaries on all levels having By-Laws should review them to be sure that they do not conflict with the Supreme Auxiliary By-Laws. All such By-Laws should be submitted to the Supreme President for approval.
- 20. The 82nd Annual Trek to Tomb of the Unknown Soldier will be October 28 thru October 31, 2016. Reservation forms and hotel information are included in the fall edition of the Cootie Courier. Please pay attention to the cut off dates. The dress required for presenting a wreath is printed in the Supreme Program Book. ANY MEMBER THAT IS NOT ATTIRED IN THE REQUIRED DRESS WILL NOT BE

ALLOWED TO PRESENT A WREATH. Please read the dress code carefully so that you will be able to present a wreath for your Auxiliary.

- 21. The VFW National Home for Children Cootie Christmas Party will be December 3, 2016. This is a wonderful experience and if you have never had an opportunity to visit the Home it will be a real treat. Reservation forms for the Banquet and hotel information is on website and also included in the next issue of the Cootie Courier. 

### From the Supreme Tomb Trek Chairman

#### Listen Cooties and Auxiliary,

I'm *ecstatic* to let everyone know that **Tomb Trek** will **CONTINUE!!** The dates for this year are October 28-30.

In March, I attended meetings with the Arlington National Cemetery leadership. They explained the intent of the letter that I received. It definitely was not about making us stop honoring our brothers, sisters, husband, wives, mothers and fathers. They wholeheartedly understood that we have a rich tradition of this honor and they want us to continue.

However, there are some extenuating factors that were explained. Currently the "Old Guard" is 30% down in manning (thank you sequestration). The Guards not only perform duties at the Tomb, but are also performing ceremonies throughout the cemetery. With manning down this low, placing more upon this group of honorable men and women is something we should not consider. Another factor is safety. The roads around the Tomb are very narrow. As in past years, when you have busses, cars, tour trollies and foot traffic it tends to become a hazard. ANC leadership is very concerned with this. Remembering past treks when we returned to the busses, it is normally packed and somewhat of a challenge to get the busses moving. To this reason is why they are very much considering closing the roads off around the Tomb.

Working with us, the leadership of ANC has offered us other memorial venues. With our origins placing back to WWI they have offered us two memorial sites where we can continue our honor; the Argonne Cross or General Black Jack Pershing grave site. We believe these locations tie in very nicely with the Cootie WWI beginnings and provide some benefits that are not available at the Tomb. These locations will allow the Cooties to conduct a unique ceremony at a unique location that will really be a standout.

On 3 April the 4th Supreme, the MOC and MOCA met. I gave a presentation of what was entailed at the meetings, and to decide the future of Tomb Trek. After completing the presentation, we had much discussion, all positive, but the most relevant is that Tomb Trek will not terminate. The decision was made to continue the laying of wreathes from Pup Tents, Grand's, Districts and Supreme at the Argonne Cross. This memorial depicts not only our beginning as the Military Order of the Cootie, it has direct linkage to Veterans Day. Another facet as to why the Argonne Cross was selected is that the grave of Sgt. Edward Younger is near this memorial. For those that don't know of Sgt. Younger, he was the individual that


selected the first Tomb of the Unknown Soldier. He was a VFW member and a Cootie from PT 1 in Washington DC. The year following the first wreath laying at the Tomb, Sgt. Younger asked Congress to extend this honor to the Military Order of the Cootie to have the honor of laying a wreath. No one in congress would deny him this request.

Once the ceremony is completed at the Argonne Cross, we have the approval for the Supreme Commander and President, along with the line officers, to continue the 82nd year of tradition and honor to lay one wreath at the Tomb.

The Tomb Trek Committee will be in full swing to ensure that this event is as memorable as before with a weekend full of friendship and fun, but most of all honor.




