MOC General Order #1 2017 - 2018

- 1. Having been duly elected at the 98th Supreme Scratch held in New Orleans, LA July 29, 2017; I, Danny R. Kramer, hereby assume command of the Military Order of the Cootie of the United States. All previous Supreme appointments have now expired. Cooties will now revert to their previous and proper tassels.
- 2. Cooties at all levels are reminded that the disassociation mandate of 1959 remains in full force and is still in effect.
- 3. Notice is hereby given that the logo, bug, official seal, hat and the name Military Order of the Cootie are the trademarked and copyrighted property of the Supreme Pup Tent, Military Order of the Cootie of the United States and may not be used without the express written consent of the Supreme Pup Tent. Violators of this order will be prosecuted to the fullest extent of the law.
- 4. Supreme Headquarters is established as being located at 604 Braddock Ave., Turtle Creek, PA 15145. Office hours at Supreme Headquarters are from 9 AM to 5PM Monday through Friday, Eastern Standard Time. Supreme Headquarters, MOC is closed for all Federal Holidays.
- 5. The Supreme Budget was approved by the Supreme Council of Administration July 29, 2017 and is in effect.
- 6. Registered Delegates to the 97th Supreme Scratch who were unable to attend can request a copy of the 97th Supreme Ad Book for the cost of \$1.50 to cover postage while supplies last. The book will be mailed to the delegates who make the request.
- 7. In accordance with Supreme Policy, all Grands are to inform Supreme Headquarters of the dates and places of their Grand Scratch so that proper representation may be assigned. Completed forms are to be mailed or e-mailed to Supreme Headquarters no later than January 1, 2018.
- 8. There is a limited supply of 97th Supreme Scratch Pins available for \$4.00 each or 3 for \$10.00. This unique pin is truly a collector's item. Cooties who did not get a chance to purchase some at the Supreme Scratch can still complete their collection by sending a note with a check for the number of pins requested. Shipping and handling is FREE on this item.
- 9. In accordance with Supreme By-Laws, Section 534, and having failed to register at least 1 delegate, the following Pup Tents are in arrears to the Military Order of the Cootie of the US and subject to suspension if not received by Nov 30, 2017. - 10. In Accordance with Supreme By-Laws Section 308, and having failed to submit an Election Report, the following Pup Tents are considered suspended until such report is submitted to Supreme Headquarters: MN 88, NJ 07, 10, 28, 57, 86, OH 04, 44 and PA 38.

- 11. - 12. Notice to all Cooties. There were 10 By-Law changes (B-1, B-3 thru B-12) and 4 Ritual changes adopted by the 97th Supreme Convention which will affect all levels of the Supreme Organization. You can order an updated edition of the Supreme By-Laws through the Supreme Supply Department.
- 13. Each Cootie will be assessed \$2.00, \$1.00 for the Supreme Commanders Special Project and \$1.00 for the annual maintenance fee MOC/MOCA House at the VFW National Home.
- 14. The 100 year Anniversary Cootie Coin is available through Supply. This coin has been designated as an official "Challenge" Coin.
- 15. Pup Tents, Districts, Grands, and Auxiliaries are reminded that they are to file IRS Form 990 within five months and fifteen days of the close of their fiscal year. Units whose income for 2016 was less than \$50,000.00 can elect to file Form 990-N an electronic informational return instead of a paper return. Those units whose income was over \$50,000.00 will still have to file the regular Form 990 or 990T.
- 16. Announcement is made of the TREK TO THE TOMB OF THE UNKNOWNS to be held on Sunday, November 5, 2017 at Arlington National Cemetery of Arlington, Virginia. Additional details on Supreme Website.
- 17. The Supreme Council of Administration will meet at 9:00AM at the Sheraton Hotel, 900 South Orme St., Arlington, Virginia on Saturday, November 4, 2017. All voting members of the Supreme Council are required to attend unless excused by the Supreme Commander.
- 18. Reporting for all programs are due no later than May 31, 2018.
- 19. Supreme Policy was approved by the Council of Administration on July 30, 2017 and is in effect.

Auxiliary members,

Another year is underway. Congratulations to all the Auxiliary Hospital Chairmen and District Hospital Commissioners. The 17-18 Hospital Program has been on the MOCA website since June 1st. Everyone should be using the new forms now. All auxiliary chairmen should be sending in monthly reports to their Grand Chairmen to be received by the last day of the month. Grand Chairmen and auxiliaries not in a Grand should be sending in monthly reports to their District Hospital Commissioners to be received by the 10th of the month. District Hospital Commissioners need to make sure that their monthly report is to me to be received by the 20th of the month. If you have not heard from a chairman in your Grand, you need to contact them and find out if there is a problem that you can help them with. There shouldn't be any "0's" by any auxiliary or Grand. As you can see by the attached Hospital report, there are lots of "0's" on the report.

A mistake that most Chairmen are making is more than one person goes on a hospital visit at the same time—that is only one visit and the number of members are the ones that went. An example is that 5 members go to the hospital on Sept 8th which equals 1 visit and 5 members. Another example is one member makes a hospital visit 3 different times. That equals 3 visits and 3 members.

Remember that travel time is .25 = 15 minutes, .50 = 30 minutes, and 1.0 = 1 hour. Do not send in 20 or 35, etc. Chairmen, please make sure that you check this carefully and correct this if needed.

The new hospital forms are easier now. If you use the one online, it even adds everything up for you. Remember that blood donations are reported under gifts. Make sure in the information column that you note the date the blood was given.

Remember that I am just a phone call or email away if you need any help.

Supreme MOCA General Order #1 Series 2017-2018

- 1. Having been duly elected and installed as Supreme President of the Auxiliary to the Military Order of the Cootie I do hereby assume the duties of the office.
- 2. All previous appointments are hereby declared null and void. All members not currently holding a Supreme Office shall revert to the proper tassels. Please refer to Supreme By-Laws Article VII, Section 707.
- 3. The Cootie Courier is recognized as the official method of communication between the Supreme Organization and all Supreme Officers, Chairmen, Grand and Local Auxiliaries. The General Orders and the President's message will be printed therein and are to be read at the first meeting following receipt of this of the current issue of the Cootie Courier and filed.
- 4. The Cootie Courier is available for free online at: https://lotcs.org/courier.html. Paper copies are available for a minimal subscription price of \$10.00 to Supreme M.O.C. Headquarters, 604 Braddock Avenue, Turtle Creek, PA 15145.
- 5. Grand and Supreme District Secretaries: General Orders, Information Letters and Minutes should be sent to the Supreme President, Supreme Treasurer, Supreme Secretary, Supreme Senior and Junior Vice Presidents and the Supreme Hospital Commissioner. The audit and Treasurer's Report should be included in the minutes. If your Grand is within a Supreme District a copy may be sent to your Supreme District President.
- 6. Secretaries on all levels: Please forward any changes of Officers or addresses to the Supreme Secretary and Treasurer.
- 7. Supreme CDs containing the Supreme Roster and Program book will be available for purchase at Tomb Trek for \$5 each.
- 8. All official communications to the Supreme President must be in writing and come through proper channels. Any local Auxiliary should send their communications to their Grand President and the Grand President to the Supreme President. Any communication not sent through proper channels will be returned to the Grand President. All decisions will come from the Supreme President in writing.
- 9. Grand Presidents: Please send the Supreme President the dates of Testimonials, Homecomings and Grand C of A meetings, as well as any special functions your Grand may hold. I would like to make as many visits as the Supreme Budget will permit.
- 10. Grand Presidents and Supreme District Presidents: In the Supreme President Program Book, CD and website there is a form to request a Supreme Representative for your Grand or District Convention. Although it seems early, please send this form to the Supreme President as soon as you have the date and location of your Convention. This will aid in making Representative assignments and obtaining the best available airfares. The rest of the information can be sent to the Supreme President as soon as it becomes available. Please have these forms completed and sent in by December 31, 2017.
- 11. Grand Presidents and Auxiliary Presidents not in a Grand: In the President's Program Book, CD and website there is a form for adding and or replacing VAVS Representatives and Deputies. If any Representatives or Deputies are not able to regularly attend their VAVS meetings they should be replaced. The President is responsible for filling out this form and sending it to Supreme VAVS Representative Rebecca Wischmeyer.

- 12. Auxiliary Treasurers: Send Transmittals with the Per Capita tax to your Grand Treasurer and make the checks payable to the Grand MOC Auxiliary. Auxiliaries not in a Grand are to send the Transmittals directly to the Supreme Treasurer. The check for the Per Capita tax should be made payable to Supreme MOC Auxiliary. As a reminder, Per Capita is \$7.00 per member effective January 1, 2017. Please indicate on the application if this is a new, transferred or reinstated member. Please be sure that three Members have signed the application where indicated. If the application does not have all three signatures it will be returned for correction. Be sure the address on the application is complete and correct. We need to have a valid mailing address for all members. Please do not hold Transmittals. Send them in as soon as possible.
- 13. Presidents on all levels: The 2017-2018 President and Treasurer are the only authorized signatures on all accounts (checking, savings and CD's). All checks must have these two signatures. Checks should be imprinted with the Auxiliary Name, Number and State. Any checks received by Supreme not having two signatures will be returned.
- 14. Audits must be done quarterly and should be completed by October 15th, January 15th, April 15th and July15th. The Audit form can be found in the current Supreme Program Book, CD and on the website. The Audit Form, bank statements, checkbook, Treasurer's Books and the books of the Secretary must be signed by at least two of the three elected Trustees. Local auxiliaries should forward the copies of the completed Audit Form to their Grand Treasurer. Auxiliaries not in a Grand should forward their Audits to the Supreme Treasurer.
- 15. Checks from the Supreme Auxiliary not cashed within 90 days of receipt will be voided. Any Auxiliaryon any level sending bad checks to the Supreme Auxiliary will be responsible for the amount of the check and any fees incurred.
- 16. Inspectors: Inspections may begin immediately. Inform the Auxiliaries of the planned inspection date so they will be prepared. Inspections may not be done at a Council of Administration meeting, but must be done at a regularly scheduled meeting of the local Auxiliary. The Inspector should verify that the books of the Secretary and Treasurer are being audited. They should also verify that the office of the Treasurer is bonded and that the bond is in the possession of the President. The Hospital Chairman should have the figures for the Hospital Program available and the green copies of the Hospital Reports should be available as well. If a problem is found during the Inspection, you should notify the Grand President immediately. The Grand Inspector will mail or email Supremes' copy of the Inspection Form to the Supreme Inspector Gail Payne, 3709 Palace Place, Virginia Beach, VA 23452 E-mail: gail101@cox.net.
- 17. Hospital Chairmen: Send your reports in monthly to your Grand Hospital Chairman. Be sure that any report that is returned for correction has the date of receipt stamped on it so that it will not be considered late when it is corrected and returned. Grand Hospital Chairmen and Auxiliaries not in a Grand should send their reports to their District Hospital Commissioners.
- 18. Clown pins can be reported for three or more clown visits between May 1, 2016 and April 30, 2017. Visits must be reported on the Hospital Report and the Clown Request form sent to the Supreme MAMA Clown.
- 19. Auxiliaries on all levels having By-Laws should review them to be sure that they do not conflict with the Supreme Auxiliary By-Laws. All such By-Laws should be submitted to the Supreme President for approval.
- 20. The 83rd Annual Trek to Tomb of the Unknown Soldier will be November 3 thru November 5, 2017. Reservation forms and hotel information are included in the fall edition of the Cootie Courier. Please pay attention to the cut off dates. The dress required for presenting a wreath is printed in the Supreme Program Book. ANY MEMBER THAT IS NOT ATTIRED IN THE REQUIRED DRESS WILL NOT BE ALLOWED TO PRESENT A WREATH. Remember you must have the new hat if you have moved up into a new office your old is not grandfathered for life. Please read the dress code carefully so that you will be able to present a wreath for your Auxiliary.

- 21. The VFW National Home for Children Cootie Christmas Party will be December 1 3, 2017. This is a wonderful experience and if you have never had an opportunity to visit the Home it will be a real treat. Reservation forms for the Banquet and hotel information is on website and will be included in the next issue of the Cootie Courier. Donations can be sent to the Supreme Treasurer Penney Howard, PO BOX 34, Flora Vista, NM 87415. Donations should be received no later than November 1, 2017 to allow time to send the total donation to the Grand of Michigan.
- 22. The Supreme President's Special Project is the "Long Trail Home Valhalla Ranch". This is a free ranch where for Veterans and military who suffer from the horrific issues connected with PTSD. 

Suicide Prevention

A DECISION WE'RE GUARANTEED TO REGRET

ecently several amazing survival stories appeared in the news. One featured the story of Georgie Knox from Alberta, Canada who struck a coyote with her car at highway speed. She heard a "crunch" sound and assumed she had killed the critter. Then, 21 miles later, someone motioned to her that there was something stuck to the grill of her car. She stopped to find - the coyote implanted in the grill, badly shaken but alive and well. Fish and Wildlife personnel inspected the coyote for injuries, then released him back into the wild.

But a far more obscure, but important story received almost no attention from the media. A 24-year-old woman in the Wuhan prefecture of China, attempted suicide by leaping from a bridge spanning the Yangtze River. The woman, identified only by her surname Li, had been publically shamed by her employer. She was so distressed that she thought death was her only escape. But she didn't die – even though the waters were bone-chilling and river swept her downstream for 25 miles – a journey that lasted five hours! Finally, police plucked her from the frigid waters alive and well.

What struck me about this woman was her comment to the police and media. She told them that, the instant she jumped from the bridge, she immediately regretted her decision. This is why she fought so hard to save her life while in the grip of the turbulent waters.

That very same comment about immediate regret has been voiced by almost all survivors of suicide attempts. Of the 1600-1800 people who have jumped from the Golden Gate Bridge, only 2% have survived the fall. And every one of them has made the same comment – the moment they lunged from the bridge they immediately regretted their decision. Suddenly their eyes were opened and they realized how precious life was to them.

A recent ABC article highlighted this same fact when it featured the story of two such survivors of suicide attempts. The survivors were Kevin Hines and Ken Baldwin. Kevin Hines told an ABC reporter, "The millisecond my legs cleared it, the millisecond of true free fall, (I felt) instant regret for my actions." Ken Baldwin agreed. "I just vaulted over (the rail), and I realized, at that moment, this is the stupidest thing I could have done."

Both men also expressed profound gratitude that they have lived to experience unforeseen joys - that they would have otherwise missed had their lives ended. Kevin Hines met the love of his life and married – his father serving as his best man. Ken Baldwin lived to give away his daughter in marriage and to see his first grandchild. Their deep depression at the time they attempted suicide blinded them to all the joys that lay ahead.

Friend, if you are depressed and feeling worthless, helpless, and hopeless – then I assure

you that your vision is impaired. You're not seeing things as they are. Your life is truly wonderful and God loves you more than you could ever imagine. And He's got so many wonderful chapters of your live left to live. Yes, there is one decision that we will always regret - the decision to throw away God's greatest gift.

PRAYER: Dear Father in heaven, open my eyes to the see all the blessings You have poured into my life and to see the possibilities of good things yet to come. Give me, O God, the will to live and fulfill Your purpose for my life. Amen.
