

From the Supreme Surgeon

Coronavirus Myth Busters

s you know, the Coronavirus (COVID-19 Virus) is taking the world by storm. The World Health Organization has provided a list of myth busters concerning the Coronavirus.

- 1. COVID-19 virus can be transmitted in areas with hot and humid climates. From the evidence so far, the virus can be transmitted in <u>all areas</u>, including areas with hot and humid weathers.
- 2. Cold weather and snow cannot kill the new Coronavirus. **There is no reason** to think that cold weather can kill the new Coronavirus and other diseases.
- Taking a hot bath does not prevent the new Coronavirus disease. **Taking a** hot bath will not prevent you from the Coronavirus.
- 4. The new Coronavirus cannot be transmitted through mosquito bites. To date, there has been no evidence that the new Coronavirus can be transmitted by mosquito bites. The virus is a respiratory virus which spreads primarily through droplets when an infected person coughs or sneezes or through droplets of saliva or discharge from the nose. Avoid close contact with anyone who is sneezing and coughing.
- 5. Are hand dryers effective in killing the new coronavirus? **No, hand dryers are not effective in killing Coronavirus.**
- 6. Can an ultraviolet disinfection lamp kill the new Coronavirus? **UV lamps** should not be used to sterilize hands or other areas of the skin. **UV radiation** can cause your skin to become irritated.
- How effective are thermal scanners in detecting people infected with Coronavirus? Thermal scanners are effective in detecting people who have a fever because of infection with the new Coronavirus. However, they cannot detect people who have become infected but are not yet sick with fever. It typically takes 2-10 days for infected people to become sick and develop a fever.
- 8. Can spraying alcohol or chlorine all over your body kill the new Coronavirus?

 No. Spraying alcohol or chlorine will not kill the virus once it has entered your body. Spraying these substances can be harmful to mucous membranes (eyes, mouth) and clothes.
- 9. Do vaccines against pneumonia protect you against the new Coronavirus? **No.** The virus is new and needs its own vaccine.


- 10. Are there any specific medicines to prevent of treat the new Coronavirus? No, currently there is no specific medicine recommended to prevent or treat the new Coronavirus.
- Are antibiotics effective in preventing and treating the new Coronavirus? **No**, antibiotics do not work on viruses.
- Does the new Coronavirus affect older people, or are younger people also susceptible? People of all ages can be infected by the Coronavirus. Older people and those with pre-existing medical conditions (asthma, diabetes heart disease) appear to be more vulnerable to becoming severely ill with the virus.
- can eating garlic help prevent infection with the new Coronavirus? While garlic is a healthy food, there is no evidence from the current outbreak that eating garlic has protected people for the Coronavirus.
- 14. Can regularly rinsing your nose with saline help prevent infections with the new Coronavirus? No, there is no evidence that regularly rinsing your nose with saline has protected people from the virus.
- 15. The best way to protect yourself from becoming infected is by frequently cleaning your hands with alcohol-based hand rub and washing them with soap and water.

Please take care of yourself and reach out to your Doctor if you feel you have been exposed.

MOC Supreme Executive Order #7 2019 - 2020



Supreme Headquarters MILITARY ORDER OF THE COOTIE OF THE UNITED STATES

"The Honor Degree of the VFW"

(2019-2020 Series)

March 17, 2020

Executive Order Number 1

In concert with the National Veterans of Foreign Wars of the of the United States' Commander-in-Chief, William 'Doc' Schmitz, effective immediately and until rescinded, Pup Tents and Grands, if possible and within the requirements of mandated state declarations, make an attempt to elect officers for the 2020-2021 year. For such Pup Tents and Grands that are not able to elect (or install) officers as a result of COVID-19, all current officers shall continue to function within their capabilities until new officers are elected and installed. It is further stipulated that no Cootie, Pup Tent or Grand be sanctioned as a result of the inability to properly execute duties or function, as mandated by state or local government declarations, as a direct cause of COVID-19.

To further explain:

- 1. The requirement for Grand and Pup Tent Inspections to compete for All-Star Grand will be waived if the inspections have not been completed as a result of COVID-19.
- 2. The requirement for Grand Pup Tents to be 80% inspected to be able to vote at the Supreme Convention is waived.
- 3. Supreme Representative travel is suspended until further notice. Supreme Officers travelling to attend Grand Scratches will do so on their own accord without compensation.
- 4. Please advise the Supreme Adjutant Gordon Lam or Supreme Quartermaster Gary Dressel of any cancellations or changes to your Grand Scratch time and/or location.
- 5. Video teleconferencing for Pup Tent and Grand Scratches are authorized if membership can be verified for the member(s) present on the video. Cooties must be physically present on video to be counted present and cast votes. Audio conferencing alone is not authorized since membership cannot be verified; voice recognition alone is not authorized.
- 6. If an election is conducted, please fill out both sides and scan the Election (Installation) Report then email to Supreme Headquarters.

MOC Supreme General Order #4 2019 - 2020

- 1. In accordance with Supreme By-Laws, Section 314(G) and 413(F) maintaining a current bond, the following Pup Tents do not have a valid bond and are considered suspended until such report is submitted to Supreme Headquarters: CA 38, NY 65.
- 2. All Pup Tents are reminded to forward copies of Election Reports for the 2020-2021 membership year to Supreme Headquarters. Pup Tents without election reports for the New Year are not in good standing and may not be represented at either their Grand or Supreme Conventions. Pup Tents whose election reports have not been received 01 May 2020 may be suspended in accordance with the Supreme By-Laws and can be declared defunct if corrective action is not taken by 01 July 2020. While it is the duty of the Installing Officer to forward election reports, Seam Squirrels, both incoming and outgoing, should take it upon themselves to see that this procedure is carried out. No Election Report= no vote.
- 3. Membership packets for 2020-2021 are in process and will be mailed in June 2020. They will be mailed to the Grand Quartermaster of record as provided on the Election Warrant. Grand Quartermasters are instructed to mail out the individual Pup Tents packages to their respective CCDB's. Pup Tents that have not sent in an Election Warrant, have not secured a Bond for the office of CCDB, or have less than nine (9) members will not receive a packet until these discrepancies have been corrected.
- 4. All Grand Commanders are reminded that their Grand must be at least 80% Inspected to have a voice or vote at the Supreme Scratch. Please review the latest Inspection Report.
- 5. In accordance with provisions of Section 534 of the Supreme By-Laws, all Pup Tents are required to register, in advance, at least one delegate to the Supreme Scratch. Failure to register shall be grounds for the Pup Tent to be declared in arrears to the Supreme Pup Tent and appropriate action will be taken. Advance registration for the Supreme Scratch is \$15.00 and \$20.00 for registration received after 30 June 2020. No Delegate fee = no vote.
- 6. 101st Supreme Scratch and 59th Convention to be held in Reno, NV at Harrah's Casino Hotel located at 219 North Center Street, Reno, NV. You can call the hotel at 775-786-3232 or use link on LOTCS.org. Please remember to mention Military Order of the Cootie convention in July 2020.
- 7. The 101St Supreme Scratch Advertising Order Form and the Booster MUST be received by headquarters no later than June 15, 2020. Forms for both are on the Supreme website. You can also email your ad to Supreme Adjutant Gordon Lam lams88101@outlook. com and mail the form & check to Supreme Headquarters, 604 Braddock Ave, Turtle Creek,PA 15145. Be creative. Remember All forms and money are sent to Supreme Headquarters.

- 8. On-site Registration for the 101St Supreme Convention will begin on 18 July 2020 during the 121St VFW National Convention. Look for the MOC/MOCA booth (Booth???).
- 9. ATTENTION: Grand Commanders, Supreme Council Members and Past Supreme Commanders. Look hard at the Registration Form. If you want to have your own vote, register as such. If you register as a Pup Tent Member, that's what you are. If you plan on flip flopping votes, you will need to register more than once.
- 10. All Supreme Officers and Chairmen are required to submit in writing a report detailing their activities no later than thirty (30) days before the start of the Supreme Convention. Reports are submitted to the Supreme Adjutant. Deadlines for submitting reports are 25 June 2020.
- 11. The Grand Commanders and Quartermasters will receive one email towards the middle of May showing what information is missing from their respective Pup Tents. No Election Reports, No Inspection, No Convention Registration.
- 12. The above listed dates are contingent with the current virus situation and Districts, Grands and Pup Tents having to cancel or delay their Conventions.



Executive Order Number 1

To: SupremeLineOfficers; Past Supreme Presidents; SupremeDistrictPresidents; Grand Presidents; SupremeAppointedOfficers; Grand Treasurers; GrandSecretaries; Supreme Chairmen

From: Marquitta Hill, SupremePresident

Subject: Auxiliary Business during the COVID-19 Pandemic

As you know Coronavirus has hit all 50 states. The severity varies from state to state. Here are some guidelines to follow during the COVID-19 Pandemic:

- 1. Supreme Representative travel is suspended until further notice.
- 2. Grand/District Presidents, please advise Supreme President of any changes to your Grand/District Convention. Please continue to communicate with your GrandDistrict Commander about your convention.
- Video/teleconferencing for Auxiliary meetings are authorized during the COVID-19 Pandemic.
- 4. When a "regular business meeting" for the election of officers, etc. cannot be held due to COVID-19, please follow the following procedure:
 - A. Begin planning ahead now. Call your officers and ask for their input.
 - B. Remember to be flexible in your planning.
- C. Get the word out of the planned changes to all members of your Auxiliary whether they attend or not:
 - 1. With proper notice given to the members, meeting dates and time may be changed.
 - 2. You may conduct a meeting via video or teleconference provided a quorum (with the President, Treasurer, Secretary, 2 other officers and members present).
 - 3. Supreme President is granting permission to any auxiliaries unable to hold schedule election/installation this month to April2020.

Please continue to follow the advertised procedures dealing with COVID-19; take care of your family and be vigilant to others whose health may already compromised.



Auxiliary to the Military Order of the Cootie General Order #4 Series 2019 - 2020

1. Elections/Installations: Auxiliaries, all elections and installations must be completed by March 31, 2020. Any installations required after March 31, 2020 must be approved by the Supreme President. Please send copies of all election/installation reports to Supreme President Marquitta Hill, Supreme Treasurer Penney Howard and Supreme Secretary Georg Jean Zimmerman.

2. Delegates: Sec. 322 – Delegates to Conventions:

- A. Delegates and alternates to the Grand Convention shall be elected at a regular meeting of the Auxiliary held not less than thirty (30) days prior to the Grand Convention; one (1) delegate and one (1) alternate for each ten (10) members or fraction thereof in good standing in the Auxiliary at the time of the election.
- B. Delegates and alternates to the Grand District Convention shall be elected at a regular meeting of the Auxiliary held not less than thirty (30) days prior to the Grand District Convention; one (1) delegate and one (1) alternate for each ten (10) members or fraction thereof in good standing in the Auxiliary at the time of the election.
- C. Delegates and alternates to the Supreme Convention shall be elected at a regular meeting of the Auxiliary held not less than thirty (30) days prior to the Supreme Convention; one (1) delegate and one (1) alternate for each fifteen (15) members or fraction thereof in good standing in the Auxiliary at the time of the election.
- D. Delegates and alternates to the Supreme District meeting shall be elected biannually at a regular meeting of the Auxiliary held not less than thirty (30) days prior to the Supreme District meeting; one (1) delegate and one (1) alternate for each fifteen (15) members or fraction thereof in good standing in the Auxiliary at the time of election.
- **Membership**: As of 2/01/2020, the Supreme MOCA membership is 84.61%. Remember to reach out to your current membership by contacting them via phone, letter or personal visit to encourage them to pay their 2020 dues. Don't forget to invite VFW Auxiliary members to join the Military Order of the Cootie Auxiliary.

If working with a medical facility, arrange to set up an account for them to purchase items in the facility's canteen. Provide them with socks, slippers, toiletry items, new PJ's, snacks... Use your imagination and work with the staff of the home care team or the medical facility to meet the veteran's needs. Let our veterans know they are not forgotten.



Changes to Supreme By-Laws

Submitted by Robert "Check" Adamczyk from the Grand of Virginia

Here is a 'clean-up' of the By-Laws to make it consistent. Section 101 and the VFW Certificate of Eligibility need to reflect the same wording at Section 103 and the Recruiting Brochure. I 'think' it would all be in line if Section 101 said "...upon committees or as officers or who have done much...." The only change would be replacing the word "and" with "or".

CORRECT

Section 103. Application.

A. Every application for membership shall be in writing and shall be filled in in every detail upon blanks to be furnished by the Supreme Pup Tent. Every applicant must be a member in good and regular standing in the Veterans of Foreign Wars and active therein and shall be investigated by a committee of at least two members.

B. An application for membership in the Military Order of the Cootie must be accompanied by a certificate verifying that the applicant has been a member in good standing in the post for the preceding six months, and has completed satisfactory service on a major Post committee or has satisfactorily performed Post duties or participated actively as a leader of Post functions; said certificate enumerating such qualifying service and showing approval of application by a majority vote of the members present and voting at a meeting of the Post shall bear the endorsement of the Post Commander attested to by the Post Adjutant.

EDIT

Section 101. Active Members.

A. Persons making application for membership in the Military Order of the Cootie must be of sound character and shall be active members of the Veterans of Foreign Wars; members who have fulfilled their work when appointed upon committees or as officers and who have done much toward promoting a greater VFW.

But all this happiness led to something called "happy tail syndrome." He sprained his tail from excessive wagging. So now he's taking meds for the pain and is encouraged to lie on his back and enjoy belly rubs.

Another dog, Zeus, a Great Dane was in the news for the very same "problem." He was too happy and he sprained his tail as well.

I mention this as a reminder that our current crisis has a *bright side*. We could mention other, far more significant benefits. For instance, few are complaining about the cheaper gas prices. Last week I paid \$1.55 per gallon – the lowest I've paid in decades. I suspect you'll find it cheaper elsewhere.

There are far more significant positive sides to the Covid-19 pandemic. For one, it's forcing people to cooperate in a crisis for the common good. Sure there are those who allow fear to dominate them and respond by hoarding. But reports abound of those who share what they have with those who have none. This has been done on the individual level and on the corporate level. Chick-Fil-A has donated thousands of meals and Tyson Foods has donated millions. Restaurants have been donating rolls of TP with takeout orders. And a member of this household has been donating eggs and TP to neighbors.

The current crisis is also teaching the younger generations (along with many older folks) an important lesson. Life will never be pain-free. No matter how much wealth we accumulate, no matter how much healthcare coverage we have, and no matter how much action our government takes, people are going to suffer. Sickness is an equal-opportunity killer and

makes no distinction between rich and poor. Medical insurance can never guard us against injury and sickness. It can only help in partially patching us up after the fact.

The fact that our Chief Executive is calling on the nation to pray for a divine intervention amidst the Covid-19 pandemic sends a profound message. It is a clear declaration to Americans that the government is not God and we should not look to it as such. Only the God of heaven can truly shield us from evil. And Covid-19 is helping us to see that. For those who look to the government, science, or themselves as God, there's nothing like a real crisis to bring us to our senses and remove every false crutch. Crisis gives us a reality check. It reveals to us the true and ultimate *source* of power, help, and salvation.

So don't dread the crises and emergencies of life. They have a redemptive purpose for humanity. They remind us of our frailty and vulnerability without God. And when we have warning of their imminence, they help us prepare to meet our Creator and be reconciled to Him so that we won't have to face Him as our Judge.

Therefore, turn to God in these times of danger and fear. Ask the Lord Jesus Christ to be your Fortress and all-encompassing Shield against sickness and disease. Even more important, ask God to make you a faithful Christian witness in these times. Hope and faith can be scarcer in times of crisis than toilet paper, though they're infinitely more needful. So inspire hope and faith with your words and your deeds.

PRAYER: Lord make me an instrument of your peace. Where there is hatred let me sow love, where there is injury, pardon; where there is doubt, faith; where there is despair, hope; where there is darkness, light; and where there is sadness, joy.

O Divine Master, grant that I may not so much seek to be consoled as to console, to be understood as to understand, to be loved as to love. For it is in giving that we receive, it is in pardoning that we are pardoned,

And it is in dying that we are born to eternal life. Amen.




