### Holidays and the Veteran

Holidays can be very difficult for active-duty military, Veterans and their families. Listed below are some helpful tips from Veterans Outreach Center Inc.

- Older Veterans sometimes become isolated from their family due to being unable to get around efficiently. Severe depression can set in when the Veteran is unable to leave a VA hospital, nursing home or be house bound.
- o Veterans aged 55-74 have a higher rate of suicide compared to civilians of the same age group.



- Veterans aged 55 or older still represent the largest number of suicides among the Veteran population.
- Younger Veterans face a different set of challenges during the holiday season. If they have recently left the military, they may be having trouble adjusting to civilian life and the holidays can add stress to the Veteran's life. Lots of noise and large crowds can trigger their PTSD symptoms.
- o Veterans aged 18-34 have the highest rate of suicide.
- o Show support for your fellow Veterans, even if it means just sitting with them and not talking.
- Active-duty members home for the holiday also experience added stress from large crowds and loud noises.
- o Remember to not ask too many questions about the military and past deployments.
- o Suicide among military members is higher than civilians.
- o Suicide rates among active-duty members has increased by 63% each year for the past 5 years.
- Family members of military service members can also experience difficulties during the holidays, especially if the member is deployed, injured or passed away. Always show respect towards the family members of a military service member because they serve in their own way.

Please, if you know someone who is alone during the holiday season or anytime of the year,

reach out to them. Ensure they are doing ok. Invite them to your holiday celebration so they don't feel so alone. If they can't get out of their house, go to them. No one wants to feel like no one cares about them. It will only take a few minutes of your time to brighten the day of someone.

These suggestions don't apply to just the holidays. It's something we should do all year. Please watch out for each other.



### What are GaGa Ball Pits?

GaGa (literally 'touch-touch' in Hebrew) is a variant of dodge-ball that is played with one ball. GaGa Ball is thought to have originated in Israel. GaGa's popularity has continued to rise in the US and is extremely popular at camps, schools, and playgrounds everywhere.



### How do you play Gaga Ball?

GaGa is great for all ages, regardless of athletic skill or abilities. It is a gentler version of dodge-ball. All players start the game inside the pit, and the mediator introduces the ball into play. The object of the game is to avoid being struck by the ball. If the ball hits you below the knee at any time, you're then "out" and must leave the pit. The last player standing is the winner. Players must dodge, run, jump, and get out of the way of being hit, while at the same time trying to hit opponents with a dodge-ball, below the knees.

### AN IDEAL SOLDIER

On this day, October 8, in 1918 Corporal Alvin C. York almost single-handedly took out 35 machine guns, killed more than 20 machine gunners, and captured 132 German soldiers. He accomplished all of this before noon on this day, 103 years ago.

York's unit, the 328<sup>th</sup> Infantry Battalion, was brought to a halt by a hail of enemy machine gun fire in the Argonne Forest. According to York, the Battalion was being cut down like hay before a mower. He was chosen to be part of the 17-man detachment assigned the mission to circle round the enemy position and attempt to take it.

But before York's men reached the objective, German guns decimated their numbers. Soon York was just one of a few still able to fight. Taking one oth-

er soldier with him, York attacked the machine gun position. He used his superb skills as a marksman to pick off dozens of enemy soldiers.

When the German commander, First Lieutenant Paul Vollmer emptied his pistol at York with no success, he offered to surrender if York would stop the killing his soldiers. York agreed and ordered the Germans to vacate their machine guns and disarm. Corporal York and the few remaining Americans gathered the 128 German soldiers and four officers and marched them back to headquarters.

For his actions that morning, York was promoted to Sergeant and awarded the Medal of Honor. He became a national hero and was celebrated in cities across America. To capitalize on his fame, many businesses offered him lucrative deals to use his name, purchase his endorsements, and even put him in show business.

But Alvin York turned them all down. In the years following WWI, Alvin York only used his fame and reputation to bring construction projects, education opportunities, utilities, and roads to the people in and around his home in Pall Mall, Tennessee. He devoted his life to many charitable causes and only authorized biographers to tell his story to raise support for these labors of love.

You see, Alvin C. York was not only a fearsome warrior. He was also a man of God

and of faith in the Bible. He was so committed to the teachings of Jesus in the Sermon on the Mount that he initially identified as a conscientious objector before the draft board. But

with the encouragement of a deeply devout Army officer and his own search of the Scripture, Alvin came to see that Christianity and military service are not incompatible. Indeed, Sergeant York would go on to credit God for protecting him and helping him "save the day" on October 8, 1918.

And throughout his days, Alvin York would remain committed to supporting America's military and even sought to enlist during WWII. But because of his age and declining health, the Army instead commissioned him as a major in the Army Signal Corps. As a Signal officer, York toured military camps and raised support for the war effort.

Above all, Alvin York reminded the country of what it means to be an American. His faith in God, selfless service, ruggedness, patriotism, and courage under fire represented the ideal that all Americans should strive for.

And for many people of faith, York demonstrated that a person could love Jesus Christ and love his own country as well. He could be committed to peace but be ready for war. And York proved that, of all people, Christian believers are best suited for service in the military. For Jesus said His followers are the "light of the world" and no place is darker and in more need of light than a combat zone.

Christian believers are a force for honesty, integrity, unity, and selflessness among their fellow soldiers. In combat they are a safeguard against atrocities and war crimes. And who is better able to offer hope to desperate soldiers and prayers to God, than someone who has a personal relationship with Jesus Christ.

We hear a lot of voices these days that say the military is no place for a Christian believer. We hear that the military is being politicized and is becoming more godless, even Marxist. That's all the more reason for a Christian believer to serve in the Armed Forces. They can be Christ's instruments of redemption and peace where help is needed most.

Pray for the members of our military. Though, sadly, the military's most senior leaders tend to be self-serving careerists and politicians, the core of the Armed Forces is committed to America and embraces traditional values. Pray for them. Pray that God will raise up more

men and women of God to fill the ranks of our military. Pray that the men and women of our Armed Forces will be physically strong, morally straight, and spiritually fit.

PRAYER: Dear heavenly Father, please bless the men and women of our Armed Forces, who serve on freedom's frontier to defend our lives, freedoms, and way of life night and day. Please raise up men and women of God to fill the ranks of our military ... and to be brave and selfless leaders over them. Please our military members physically strong, morally straight, and spiritually fit. Please grant them supreme success in their mission to defend our nation and to deliver the oppressed. And please, dear God, protect them from all danger and harm and bring them safely back from deployment into the arms of their families and loved ones, through Jesus Christ our Lord, Amen.


