Summer Safety Tips

Summer is fast approaching and with that comes vacations and more time outdoors. Listed below you will find some tips to make your summer healthy and safe.

- 1. Avoid areas where insects gather or nest (pools of still water, flower gardens and uncovered foods). Remember that insects are attracted to scented soaps, hair sprays and perfumes. Using bug spray with DEET will help keep mosquitoes and ticks away.
- 2. Stay hydrated. Drink water at least every 20 minutes. This will help prevent heat stress and heat stroke. If you are going to stay outside for more than one hour, add a sports drink to replenish your electrolytes.



- 3. While enjoying a playground with your children, be sure that the equipment is in good shape. Rotten wood and plastic can have sharp edges that can cause scrapes or eye injuries. Ensure that slides and other surfaces are cool enough to be comfortable.
- 4. When heading out for a family bike ride, be sure to check the local laws regarding bike riding. Everyone should wear a helmet.
- 5. Educate yourself in recognizing poison ivy and poison oak. If you are hiking, it is recommended that you carry a book with photos of poisonous plants.
- 6. Let someone know where you are going and when you will be back. If hiking or camping, take a first aid kit. The kit should include antibiotic ointment, anti-itch gels, Ace bandage, adhesive bandages, emergency hydration and electrolyte replacement drinks or packs.
- If you see someone struggling in a pool or lake, throw a Coast Guard approved flotation device to the person in the water or use a pole to reach them. Use these basic water safety tips:
 - a) Set limits based on each person's ability.
 - b) Don't let anyone play around drains and suction fittings.
 - c) Don't allow children to have breath holding contests underwater.
 - d) Stick to beaches, pools and lakes with lifeguards.
- 8. Use broad-spectrum sunscreen. Limit time in the sun between 10 a.m. and 4 p.m.

- 9. Prepare an emergency weather kit. The kit should include non-perishable food, flashlights, water, first aid kit, extra medications, etc.
- 10. Be a defensive driver. Put away your cell phone. If you're tired, pull over for a quick nap. Don't drink and drive.
- 11. Don't ignore thunder. Use the 30-30 rule. Once you see lightning, count to 30. If you hear thunder before you hit 30, go inside. Also, avoid taking a bath or shower during a thunder storm. Lighting can travel through plumbing.
- 12. Stay active. You need 150 minutes of moderate aerobic exercise each week to stay healthy.
- 13. Eat healthy food. Make a stop at a local farmers market to pick up fresh seasonal produce. Eating water rich foods can help keep you hydrated during the hot summer months.
- 14. Cook food the same day as your picnic. To prevent illness, practice the four food safety steps: clean, separate, cook and chill.
- 15. Practice fireworks safety. When using fireworks, keep a safe distance once lit and don't point fireworks toward the face of body. Keep water nearby to extinguish fireworks.
- 16. Watch for power lines. When doing activities such as kite flying, drone flying and tree climbing, watch out for low-hanging power lines. If one of your gadgets gets stuck in a power line, call the power company. Do not try to retrieve it yourself. If a power line falls down due to a storm, stay a minimum of 25 feet away.
- 17. Watch your grill. Practice food and fire safety. This includes only grilling outdoors, keeping kids and pets away, keeping the grill cleaned of grease and fat. Never leave the grill unattended.
- 18. Give wildlife space. Ensure you give all wildlife you encounter plenty of space. When feeding ducklings on the pond or deer from your hands, remember they are wild and can be unpredictable. This also goes for snakes, bears, bees, alligators, bird and other roaming critters.
- 19. Prevent fires. The number one cause of house fires are cooking fires. Make sure that you keep any fire activities a minimum of 10 feet away from your home. Keep a fire extinguisher handy and a hose nearby to put out any unexpected fires.
- 20. Watch your step. When you spend time outdoors, remember to always wear shoes and watch where you step. Summertime is an active time for creatures like alligators, snakes, bees and other outdoor hazards. Look before you step, especially if you're exploring your favorite local parks.

- 21. Check you car. Before you lock your car, check for pets and children who may have been left behind. When it is 78 degrees outside, the interior of your car can quickly reach 120 degrees within minutes.
- 22. Mow with care. When mowing the yard, be sure you wear long sleeve shirts and pants along with safety goggles. Wearing close toed shoes is a must.



Objective: The Supreme Commander desires that special recognition be given to outstanding Sky Pilots and Chaplains in the Military Order of the Cootie.



The Supreme Sky Pilot or Chaplain of the Year Program is an excellent opportunity to recognize your best Sky Pilot or Chaplain. Sky Pilots of the Pup Tent, Chaplains of the Grand, District or Area, have been recognized at the Supreme Scratch each year as *Supreme Sky Pilot of the Year* or *Chaplain of the Year* since Cootie Year 1975-1976.

Selection:

- 1. Selection of the Supreme *Sky Pilot of the Year or Chaplain of the Year* is done from letters of nominations sent by Pup Tent Seam Squirrels, Grand District and Area Commanders, Grand Commanders, and Supreme Council Members to the Supreme Chaplain.
- 2. Letters of nominations are judged by a Select Committee of no less than three people who are NOT members of the MOC or VFW, but who understand fully the work or labor of the Chaplain. - 5. Letters of nomination should contact facts, not just words. We have Sky Pilots and Chaplains who do great work in this, and our parent, organizations. So please nominate them and get them recognized by sending your letter to the Supreme Chaplain.
- 6. Do not let your Sky Pilot or Chaplain down. Please make a nomination for this honor. If you don't nominate them, they may not be recognized.






Pup Tent 11 Valentine's Day Donation






