
Triple 'S' Memorial Day and Other Ceremonies Memorandum

From the Supreme inspector

Listen up Cooties,

Well another Cootie year has come & is almost over. By the time you are seeing this, we will be swarming together in Louisville to select our new Lousy Supreme leaders. This has been a Lousy Supreme year as all Grands finished at 100% inspected. I say Boo to you for that! In plain talk, that was fantastic! Let's do it again this year! Hopefully earlier. Below is a reminder about the inspection procedure and where to send completed inspections. Let's have a phun new Cootie year!

Per Article III, Section 330

Section 330. Inspections.

Any Pup Tent that has not been properly inspected shall be excluded from all representation in the Grand and Supreme Scratches. The inspection report must be



received by the Grand and Supreme Inspectors thirty (30) days prior to the said Scratch. Pup Tents instituted/installed during the current fiscal year shall be exempt from inspection until the following fiscal year.

Per Article IV, Section 415

Section 415. Duty of the Grand Inspector.

- **A.** The Grand Inspector shall have charge of and supervise instruction and inspection in the Grand Pup Tent and shall ensure inspection of the Grand Pup Tent and all Pup Tents, Districts, or Areas within the Grand Pup Tent.
- **B.** They shall require that all books and records of each Pup Tent be inspected at least once during their term.
- C. They shall require that the Supreme, Grand and Pup Tent Bylaws be enforced.
- **D.** They shall require that the opening and closing of Scratches, the order of business and rules of order be followed, and that the initiation of atoms and other ceremonies are conducted as prescribed by the ritual.
- E. They shall report on the decorum of the Pup Tent scratches.
- **F.** They shall make a report in detail as to the Pup Tent finances, records and property at the time of inspection.

- **G.** They shall appoint, with the approval of the Grand Commander, Deputy Inspectors. Deputy Inspectors shall be qualified for the work that their office requires.
- **H.** They shall perform such other duties incident to their office as may be required of them by the Supreme Inspector, Grand Commander and Bylaws.
- **I.** Deputy Grand Inspectors shall assist the Grand Inspector to carry out the duties of their office and the provisions of the Bylaws and instructions or orders from Supreme or Grand Headquarters.



What about if you've already completed your 3rd degree initiation? Not to worry, the degree is retroactive. So, have the present Seam Squirrel (the issuing authority) print your degree.

THE BEHEITS OF SLEEP

t seems that lately everyone is talking about the benefits of getting enough sleep. The proper amount of sleep can boost your brain power, improve weight management, and reduce inflammation and stress. Sleep also plays a crucial role in hormone regulation, tissue repair and overall health.

Listed below are a few of the health benefits of getting enough sleep:

- Regulated blood sugar
- Improved mood
- Restored immune system
- Athletic performance

- Maintaining a healthy weight

If you don't get enough sleep, you may become sleep deprived. The signals your body sends you if you don't get enough sleep are as follows:

- Lack of motivation
- Difficulty focusing
- Difficulty with memory
- Dark circles under the eyes
- More hunger than usual, causing you to gain weight
- Weakened immune system

Section 322 - Delegates to Conventions, section B

Delegates and Alternates to the Supreme Convention shall be elected at a regular meeting of the Auxiliary held not less than thirty (30) days prior to the Supreme Convention: one (1) delegate and one (1) alternate for each fifteen (15) members or fraction thereof in good standing in the Auxiliary at the time of election.

The Auxiliary Secretary shall send a complete list of elected delegates and alternates to the Supreme Credentials Chairman, **Kathy Holmes** immediately following election, either by Email: **holmeske@att.net** or by mail: **13820 NE 139th St., Kearney, MO 64040**

The number of Delegates allowed per auxiliary will be based on per capita tax (membership dues) that are received by the Supreme Treasurer prior to the time Delegates are elected, no later than June 27, 2024.

In your Auxiliary, **Supreme Officers, Supreme Appointed Officers** and **PSPs** that carry their own vote at Supreme should be identified separately. They are in addition to your elected Auxiliary Delegates / Alternates.

NOTE: if they might need to vote as an Alternate (for example, if there is a chance that no one else from your Auxiliary will attend, you may also list them as an Alternate for your Auxiliary. The Officer must determine at Convention which position they represent with their vote.

Grand Presidents have their own vote (are not an elected Delegate). List them separately as 2024-2025 Grand President, unless they are acting as an Auxiliary Delegate.

MOC Auxinary Proposed By-Law Changes

Membership numbers are at a critical point, with many auxiliaries closing and not another auxiliary close by to transfer to, This Proposal is to address loosing members who may wish to remain a member of the Military Order of the Cootie Auxiliary as a Member at Large.

PROPOSED ADDITION to By Laws

Article 1 – Membership

Sec. 109 (new) - Supreme Members At Large

- A. Anyone eligible for membership and already a member in Good Standing in an Auxiliary, may become a Supreme Member At Large upon:
 - 1. Submitting a completed application to the Supreme Treasurer
 - 2. Includes current membership number
 - 3. Payment of Annual dues
 - 4. Fees in the amount determined by the Supreme Council of Administration.
- B. Anyone eligible for membership, who has not paid dues for one (1) year or longer, and wishes to rejoin as a Supreme Member at Large, may do so upon:
 - 1. Submitting a completed application to the Supreme Treasurer
 - 2. Includes previous membership number (will be verified by Supreme Treasurer)
 - 3. Payment of Annual dues
 - 4. Fees in the amount determined by the Supreme Council of Administration.
- C. The Member shall transmit to the Supreme Treasurer <u>Twenty</u> dollars <u>\$20.00</u> annual dues to be effective for the current calendar year, based upon date of submission.
- D. The Supreme Treasurer will send a membership card to the member annually, once dues are received.

Sec. 110 (new) - Members At Large - Rights of

- A. Any Member At Large May
 - 1. Attend Auxiliary, Grand or Supreme meetings, but is unable to enter into any discussion during the business session of these meetings.
 - 2. Participate and volunteer in Supreme Programs and report participation to the appropriate Supreme Chairmen.
- B. Any Member At Large May Not
 - 1. Hold any office, chairmanship, or be a VAVS representative or deputy, etc. at the Auxiliary, Grand or Supreme level.
 - 2. Be a Delegate to any Grand or Supreme Convention and therefore cannot vote.

Sec. 111 (new) - Members At Large – Defunct Auxiliaries

- A. Any member in an Auxiliary that goes defunct and dues are paid for the current calendar year, will automatically be placed in 'Member At Large' status. Continued membership in the Military Order of the Cootie Auxiliary as a Member At Large, will require payment to the Supreme Treasurer of Twenty dollars \$20.00 for the calendar year.
- B. The Supreme Treasurer will send a membership card to the member annually, once dues are received.

B: To install new officers, at least ten (10) members shall be paid for the current year by the time of installation. The installation shall be conducted by a member in good standing, who is a past Auxiliary President or one who has held a higher office in the MOC Auxiliary. The President elect will select the Installing Officer. The Secretary will send in the officer's name to the Grand Secretary in time to permit the issuance of the Warrant or to the Supreme Secretary, where no Grand exists.

Proposed Resolution:

Sec 305 - Installation of Officers:

B. Local Auxiliary/Grand/Supreme Level. Officers shall be installed at a regular or special meeting at the same time as the officers of the corresponding Pup Tent. The installation may be held publicly. The President elect will select the Installing Officer. The following members in good standing may conduct the installation ceremony on all levels.

- 1. A member who is a Past or current MOC Auxiliary President (all levels).
- 2. A member who has held a higher elective office in the MOC Auxiliary.
- 3. Or a Past or current Seam Squirrel (Commander)/Grand Commander/Supreme Commander or higher office.

The Secretary will send a completed Installation Report to the Grand Secretary or to the Supreme Secretary and Supreme Treasurer, where no Grand exists.

C. Assuming Duties: At local Auxiliary/Grand level, officers will assume their duties at the same time as their Pup Tent/Grand Pup Tent Officers. Supreme Officers will, immediately after their election, enter upon the duties of their respective offices after the adjournment of the meeting at which they were installed.

MOCA By-Laws 2024: Proposed Change to Section 201

Current: Sec 201- Formation

A: An Auxiliary shall not be formed until approved by an M.O.C. Pup Tent at a stated meeting, due notice of proposed formation having been given to the entire membership of the MOC Pup Tent seven (7) days prior to such meeting. The Auxiliary must also be approved by the Veterans of Foreign Wars Post where the Pup Tent is chartered. Each Auxiliary must be assigned the name and number of the Pup Tent which it is to be affiliated and shall be governed by, and under the jurisdiction of, the Pup Tent whose name and number it will bear.

B: An Auxiliary to the MOC Pup Tent may be formed by Charter from the Supreme Treasurer of the Auxiliary to the MOC upon application of ten (10) new or rejoined applicants who are members of the Auxiliary to the Veterans of Foreign Ward, holding current dues cards in accordance

with the By-Laws of the Auxiliary to the Military Order of the Cootie. Transfers cannot be included on the charter application but may become charter members after the Auxiliary is chartered.

Proposed Resolution: Sec 201: Formation

A: An Auxiliary shall not be formed until:

- 1. Approved by an M.O.C. Pup Tent at a stated meeting, due notice of proposed formation having been given to the entire membership of the MOC Pup Tent seven (7) days prior to such meeting.
 - 2. Approved by the Veterans of Foreign Wars Post where the Pup Tent is chartered.

B: Each Auxiliary must be assigned the name and number of the Pup Tent which it is to be affiliated and shall be governed by, and under the jurisdiction of, the Pup Tent whose name and number it will bear.

C: Prior to instituting an Auxiliary, an Organizer will be appointed by the Grand/Supreme President. This Organizer shall be a member of the Military Order of the Cootie Auxiliary. The Organizer shall hold three (3) monthly meetings with potential members. This is to ensure that the members understand what the Auxiliary does as well as the duties and responsibility of each office. Once it is determined that these individuals are interested, then an Instituting Officer will be appointed by the Grand/Supreme President and they will continue the instituting process.

D: Once the above process has been completed the Auxiliary to the MOC Pup Tent may be formed by submitting an application for a Charter from the Supreme Treasurer of the Auxiliary to the MOC of not less than fifteen (15) new or rejoined applicants who are members of the Auxiliary to the Veterans of Foreign Wars, holding current dues cards in accordance with the By-Laws of the Auxiliary to the Military Order of the Cootie. Transfers cannot be included on the charter application but may become charter members after the Auxiliary is chartered.

E: The Instituting Officer or a mentor shall attend a least four (4) meeting within the first year in person or via Zoom.

F: No Auxiliary shall be formed when the M.O.C. Pup Tent is chartered under a Provisional or Probationary Charter.
















"The Honor Degree of the Veterans of Foreign Wars"



































VFW Post 3103 and Auxiliary @cookingwithaveteran Fundraiser for the VFW National Home Fredericksburg, VA

As we all know the motto: "No One Does More for Veterans" is more than mere words. It is a mission of members of the Veterans of Foreign Wars. Something that VFW and Auxiliary members at VFW Post 3103 take very seriously. Connections, contacts and communication were key to accomplishing what was needed in the community and to conduct a successful fundraiser for programs like the VFW National Home. That is exactly what happened on March 8th when Cooking with a Veteran came to the Post.

What started as a simple cooking for local veterans in need has turned into a mission to ensure no veteran goes hungry. The Post first started communicating



with Veteran Chef Rogers through the District 8 CMDR and Past Post CMDR Todd Taylor who talked of doing something together. The District CMDR introduced Rogers to Post CMDR Sheri Moore and a simple email in January from Comrade Chris Cruz got the ball rolling. Veteran Chef Rogers and his service dog Grunt of @cookingwithaveteran were planning to attend the VFW Legislative Conference in Washington, DC in early March. Since he would be in our local area on his way home, he wanted to see if he and the Post could work together on an event. VFW Post 3103 Canteen is open every Friday

evening at 1700 for a homecooked meal, drinks and camaraderie. We quickly came up with the idea of The Grunt Chef helping us do a special dinner for any local veterans that would be a 'by donation only' fundraiser for the VFW National Home.

While Veteran Chef Rogers worked with us on the menu, being sure that it was something that we would enjoy, it was up to the Post to plan, make arrangements and spread the word for the event locally. Members and the Auxiliary chimed in helping as they could. Great assistance came from the Auxiliary who worked hard to get donations from local markets and vendors like Weis and Walmart to help cover the costs. Volunteers from both the Post and Auxiliary worked under the tutelage of Veteran Chef Rogers in doing the prep work on Thursday and all of the final meal prep and cooking on that Friday. Everyone learned a lot along the way and the event in the form of photos and videos was featured on @cookingwithaveteran social media.

The meal turned out to be a huge success with the Post and Auxiliary serving over 100 meals. The menu consisted of pork schnitzel, mashed potatoes and creamed corn or baked ziti and salad with cheesecake for dessert. We had several raffles that night as well, including Veteran Chef Dave's @cookingwithaveteran cookbooks, k-bar and grill set as some of the raffle items. He also brought along the MOC Tennessee Chess Pie pins for us to purchase to help support the program. The Post and Auxiliary were able to raise \$2000 for the VFW National Home.

The two days that Chef Dave Rogers spent with us were busy beyond the food preparation. He was able to visit with the Veterans On Board group that meets at our Post Home on that Friday morning. We also took him to visit Black Horse Forge (<u>Black Horse Forge – Veterans Non-Profit</u>), which is run by veterans and serves veterans by teaching them blacksmithing skills. They presented him with a very fancy chef's knife made in the forge by a veteran, which you will see often if you watch his cooking programs on social media. While visiting Black Horse Forge, we also visited their neighbor, Loyal Drums (<u>Handmade Artisan Products - Rope Tension Drums - Loyal Drums</u>), which is another veteran owned business.

When asked how he thought the event went Rogers commented "Events like this is why I love what I do. We did more than feed the body, we fed the soul, mind and heart." The Post and Auxiliary showed their appreciation for Veteran Chef Rogers' work and dedication to helping veterans by presenting him with a certificate and a gift basket for him and Grunt. He presented the Post with his challenge coin and engraved @cookingwithaveteran cleaver. This was Chef Dave's first visit/event in the state of Virginia, but we are hoping it will not be his last.




